



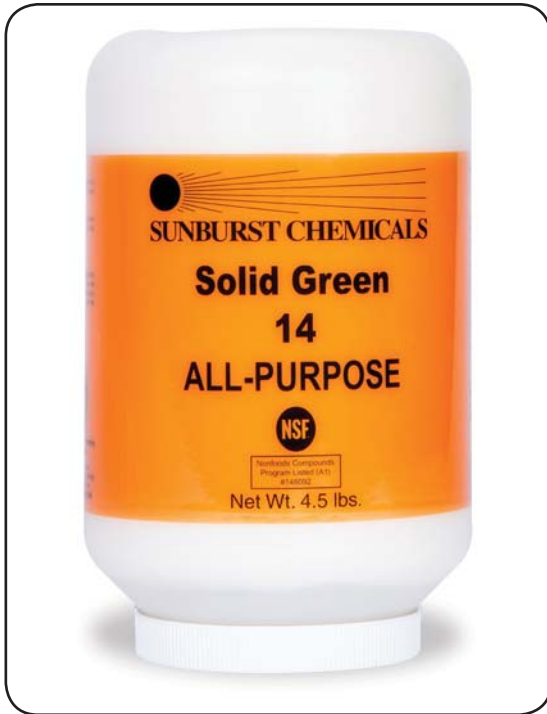

## DIRECTIONS FOR USE:

**TRIGGER SPRAY BOTTLES:** Place bottle under dispenser with tube in bottle. Fill bottle with use solution by turning valve to "on" position and turn valve to "off" position after desired level is reached.

### FLOORS, WALLS, GENERAL CLEANING:

R2U Dispenser: Turn valve to "on" position. Fill container to desired level and turn valve to "off" position.

P4C Dispenser: Fill the container with water to desired level. Then push button in and release to add chemical concentrate.

Master Blaster: Remove cap. Place upside down in dispenser. Apply thoroughly to surfaces being cleaned. Rinse with clean water.

**HEAVY DUTY CLEANING:** Mix stronger solution by using either more concentrate or less water. Mop or scrub surfaces. Rinse with clean water.
