This product is an EPA registered, ready-to-use hydrogen peroxide disinfectant, cleaner, mildewstat, virucide and deodorizer for use on hard, nonporous surfaces in medical and non-medical facilities as well as animal facilities. Effective against listed bacteria, viruses and animal viruses with a 3 minute contact time, including *Enterobacter aerogenes*, *Escherichia coli*, *Klebsiella pneumoniae*, Methicillin Resistant *Staphylococcus aureus* (MRSA), *Pseudomonas aeruginosa*, *Salmonella enterica*, *Staphylococcus aureus*, Herpes Simplex Type 2, HIV-1, Influenza A/Hong Kong, Norovirus and Feline Calicivirus.

Surfaces must remain wet for 3 minutes. Follow label directions for disinfecting procedures.
